FACTS	WHAT DOES THE INX DIGITAL COMPANY, INC. ("INX") DO WITH YOUR PERSONAL INFORMATION?
Why?	Under federal law, personal information means any information that identifies or is linked or reasonably linkable to an individual. Federal law gives consumers the right to limit, to some extent, the sharing of your personal information. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do with your personal information.
What?	<p>The types of personal information we collect and share depend on the product or service you have with us. This information can include:</p> <ul style="list-style-type: none"><li>• Social Security number and employment information;</li><li>• Photo identification;</li><li>• Your address, date of birth;</li><li>• Account balances, transaction history and credit information;</li><li>• Assets and investment experience;</li><li>• Information about user transactions, including trade frequency and trade size;</li><li>• Other information about your job, position, assets and financial sophistication.</li></ul>
How?	All financial companies need to share customers’ personal information to run their everyday business. Below, we list the reasons financial companies can share their customers’ personal information; the reasons INX may share customers’ personal information; and whether you can limit this sharing.

### Why can't I limit all sharing?

Federal law gives you the right to limit only:

- sharing for affiliates' everyday business purposes — information about your creditworthiness
- affiliates from using your information to market to you
- sharing with nonaffiliates to market to you

State laws and individual companies may give you more rights to limit sharing.

### What happens when I limit sharing for an account I hold jointly with someone else?

Your choices will apply to everyone on your account.

## Definitions

### Affiliates

Companies related by common ownership or control. They can be financial and non-financial companies.

This Policy applies to all the affiliated companies of The INX Digital Company.

### Non-affiliates

Companies not related by common ownership or control. They can be financial and non-financial companies.

- Non-affiliates we share with can include third-party identity and background check services.

### Joint marketing

A formal agreement between non-affiliated financial companies that together market financial products or services to you.

- We don't currently have any joint marketing partners.

## Other Important Information

### Vermont Residents

If your INX account has a Vermont address, we will not share personal information we collect about you with third parties unless the law allows or you provide authorization.
